

**ORDINANCE #953**  
**AN ORDINANCE OF THE BOROUGH OF OCEANPORT IN THE**  
**COUNTY OF MONMOUTH SETTING THE SALARY RANGES OF CERTAIN BOROUGH OFFICERS AND**  
**BOROUGH EMPLOYEES**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Oceanport, in the County of Monmouth, State of New Jersey that the purpose of this Ordinance is to amend the ordinance entitled "An Ordinance to Fix and Determine the Salaries of Certain Borough Officials" passed and approved on March 16, 1939, as last revised and passed on February 19, 2015.
