

# Did Hurricane Sandy impact your business?

## Need financial assistance?

Whether your business loss is temporary or permanent, you and your employees may qualify for unemployment insurance or disaster unemployment assistance.

The first step in applying for disaster unemployment assistance is filing an unemployment claim. File your claim online at [www.njuifile.net](http://www.njuifile.net) — online filing is fastest. You will be asked the reason for your separation from your employer. Select “Other,” then type “Hurricane Sandy” in the comment box.

If you cannot file online, file by phone:

*You must file unemployment claims resulting from Hurricane Sandy by December 3, 2012.*

## Need a temporary location?

You can use phones, photocopiers, and fax machines at your local One-Stop Career Center. Some locations may have limited office space available. Call your local Business Service Representative, listed on the back.


