ORDINANCE #1031

CAPITAL ORDINANCE PROVIDING FOR THE ACQUISITION AND INSTALLATION OF A RADIO TOWER AND ASSOCIATED EQUIPMENT AT THE MUNICIPAL COMPLEX, BY AND IN THE BOROUGH OF OCEANPORT, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$91,998 THEREFOR (\$91,998 FROM MONIES RECEIVED FROM THE SPORTS WAGERING ECONOMIC DEVELOPMENT AUTHORITY PROGRAM OF THE STATE OF NEW JERSEY) TO PAY FOR THE COST THEREOF

WHEREAS, the Borough of Oceanport, in the County of Monmouth, State of New Jersey (the "Borough"), wishes to undertake the acquisition and installation, as applicable, of a radio tower and associated equipment at the municipal complex; and

WHEREAS, the cost of said improvements or purposes is estimated to be \$91,998; and

WHEREAS, the Borough desires to authorize the appropriation and expenditure of \$91,998 from monies received from the Sports Wagering Economic Development Authority Program of the State of New Jersey to undertake said improvements.

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF OCEANPORT, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The capital improvements or purposes described below are hereby authorized as general capital improvements to be undertaken by the Borough. For the said improvements or purposes, there is hereby appropriated the amount of \$91,998 from monies received from the Sports Wagering Economic Development Authority Program of the State of New Jersey.

SECTION 2. The capital improvements or purposes hereby authorized are the acquisition and installation, as applicable, of a radio tower and associated equipment at the municipal complex; and also including all engineering and design work, construction planning, preparation of plans and specifications, permits, bid documents, inspections and contract administration; and all work, materials, equipment, labor and appurtenance necessary therefor or incidental thereto. All expenditures for such improvements or purposes shall comply with Local Public Contracts Law N.J.S.A. 40A:11-1, et. seq.

SECTION 3. The expenditures for the improvements or purposes set forth in Section 2 hereof are hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer or any other official/officer of the Borough is each hereby authorized and directed to execute, deliver and perform any

agreement to undertake the improvements or purposes set forth herein and to effectuate the transaction contemplated hereby.

SECTION 4. The capital budget of the Borough is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the Office of the Clerk and is available for public inspection.

SECTION 5. This ordinance shall take effect immediately after final adoption and approval by the Mayor as described in N.J.S.A. 40:49-2
