## Mayor's Message

The Borough of Oceanport has welcomed the New Year with some dramatic changes, not the least of which is Arcticlike weather and the windswept, not so fluffy white landscape that accompanied our first winter storm. Lucky for us, the members of Oceanport's incredible Department of Public Works were, once again, more than equal to whatever Mother Nature threw at them. By all accounts, our Borough's roads were cleared in a coordinated and orderly fashion and were in much better shape than most of the surrounding communities. We are certainly lucky to have such a dedicated, professional, and caring group of workers.

Unfortunately, while our roads were free of snow, once again we had quite a problem with snow removal from our sidewalks. In 2013, the Borough adopted an ordinance requiring, in part, that the owner, tenant or occupant of any building or land abutting a sidewalk clear the sidewalk of snow or ice to a width of at least two feet within 48 hours after the cessation of snowfall or formation of ice. The exact language of the ordinance can be found in section 295-3 of the Borough's Code.

Under the ordinance, those who choose not to clear their sidewalks within 48 hours can be ticketed and fined. There are those in our little burg, however, who believe they do not have to shovel their sidewalks because the Borough may have put in sidewalks as part of a DOT or Safe Routes to School Program Grant. Let me disabuse them of that belief right now: To put it simply, like it or lump it, if you've got a sidewalk abutting your house, it's YOUR responsibility to maintain it. Going forward, those who choose not to clear their sidewalks within 48 hours WILL be ticketed and fined.

Quite frankly, though, we should not have to ticket anybody. This is an issue that should not be on the government's agenda because it is an issue rooted in being a good neighbor. If you have the fiscal or physical ability to shovel your walk, then you should shovel your walk because it's the right thing to do in a small community. If you have a neighbor who doesn't have the ability to shovel their walk, get a couple of people together and shovel the walk for them because it's the right thing to do in a small community. Actually, it is the right thing to do in any size community. This is Oceanport, not Gotham City, and neighbors should be working together to solve first world problems such as this. In fact, as evidenced by some wonderful people in town --- like Joe LaValle and his kids ---who have volunteered on the Oceanport Resident's Facebook page to shovel other people's walks for free if they



#### **Overnight Parking Ban**

Just a friendly reminder to please be aware overnight parking on Borough streets is prohibited when the streets are covered in snow - whenever snow has fallen, and the accumulation is such that it covers the streets. The parking prohibition shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.



#### **Dog & Cat License Renewal**

The Borough began issuing 2018 dog and cat licenses beginning the first of the year. Please come into Borough Hall to pick up or renew your pet's license. Licenses are required to be renewed by January 31st, 2018. In accordance with state regulations, your pet's rabies vaccination must be valid through October 2018 for a license to be issued. 

#### Notice Publicizing the Map Information Service

**NOTICE TO:** Public, Lending Institutions, Real Estate and Insurance Agents

SUBJECT: Flood Insurance Rate Map Zone Information

The Borough of Oceanport currently participates in the Community Rating System (CRS) under the National Flood Insurance Program (NFIP). The CRS administered by the Federal Emergency Management Agency (FEMA), provides that a community, who performs specific activities related to flood protection, flood awareness, and flood prevention, can secure reduced flood insurance premiums for all property owners within the community.

As a public service, the Borough of Oceanport will provide you with the following information upon request:

- Whether a property is in or out of the Special Flood Hazard Area (SFHA) as shown on the current Flood Insurance Rate Map (FIRM) of the City.
- Additional flood insurance data for a site, such as the FIRM zone and the base flood elevation or depth, if shown on the FIRM.
- Oceanport Borough has a handout on the flood insurance purchase requirement that can help people who need a mortgage or loan for a property in the SFHA.
- Oceanport Borough has copies of completed FEMA Elevation Certificates for buildings built in the floodplain over the past several years.

If you want to make an inquiry, please provide the street address and, if available, the lot, and block number. Just drop by the Tax Office in Borough Hall located at 315 East Main Street. Staff in the office can provide the needed information. There is no charge for this service.

Oceanport Borough staff within the Tax Collectors office and Office of Emergency Management will be able to provide you with information; however, the staff will not decide for you as to whether you need the coverage.

Office of Emergency Management The Mandatory Purchase of Flood Insurance Requirement

This community participates in the National Flood Insurance Program (NFIP) which makes federally backed flood insurance available for all eligible buildings, whether they are in a floodplain or not. Flood insurance covers direct losses caused by surface flooding, including a river flowing over its banks, a lake or ocean storm, and local drainage problems.

The NFIP insures buildings, including mobile homes, with two types of coverage: building and contents. Building coverage is for the walls, floors, insulation, furnace, and other items permanently attached to the structure. Contents coverage may be purchased separately, if the contents are in an insurable building.

**Mandatory Purchase Requirement:** The Flood Disaster Protection Act of 1973 and the National Flood Insurance Reform Act of 1994 made the purchase of flood insurance mandatory for Federally backed mortgages on buildings located in Special Flood Hazard Areas (SFHAs). It also affects all forms of Federal or Federally related financial assistance for buildings located in SFHAs. The SFHA is the base (100-year) floodplain mapped on a Flood Insurance Rate Map (FIRM). It is shown as one or more zones that begin with the letter "A" or "V."

The requirement applies to secured mortgage loans from financial institutions, such as commercial lenders, savings and loan associations, savings banks, and credit unions that are regulated, supervised or insured by Federal agencies such as the Federal Deposit Insurance Corporation and the Office of Thrift Supervision. It also applies to all mortgage loans purchased by Fannie Mae or Freddie Mac in the secondary mortgage market. Federal financial assistance programs affected by the laws include loans and grants from agencies such as the Department of Veterans Affairs, Farmers Home Administration, Federal Housing Administration, Small Business Administration, and the Department of Homeland Security's FEMA.

How it Works: Lenders are required to complete a Standard Flood Hazard Determination (SFHD) form whenever they make, increase, extend, or renew a mortgage, home equity, home improvement, commercial, or farm credit loan to determine if the building or manufactured (mobile) home is in an SFHA. It is the federal agency's or the lender's responsibility to check the current Flood Insurance Rate Map (FIRM) to determine if the building is in an SFHA. Copies of the FIRM are available for review in most local government building or planning departments. Lenders may also have copies or they may use a flood zone determination company to provide the SFHD form. If the building is in an SFHA, the Federal agency or lender is required by law to require the recipient to purchase a flood insurance policy on the building. Federal regulations require building coverage equal to the amount of the loan (excluding appraised value of the land) or the maximum amount of insurance available from the NFIP, whichever is less. The maximum amount available for a single-family residence is \$250,000. Government-sponsored enterprises, such as Freddie Mac and Fannie Mae, have stricter requirements. The mandatory purchase requirement does not affect loans or financial assistance for items that are not covered by a flood insurance policy, such as vehicles, business expenses, landscaping, and vacant lots. It does not affect loans for buildings that are not in an SFHA, even though a portion of the lot may be. While not mandated by law, a lender may require a flood insurance policy, as a condition of a loan, for a property in any zone on a FIRM. If a person feels that an SFHD form incorrectly places the property in the SFHA, he or she may request a Letter of Determination Review from FEMA. This must be submitted within 45 days of the determination. More information can be found at fema.gov/how-request-flood-hazard-determination-review-fema.



## From Oceanport OEM: What Winter Weather Warnings Mean

What is the difference between a winter storm watch, warning, or advisory?

Knowing the difference means how much time you have to prepare for the storm.

The National Weather Service (NWS) issues outlooks, watches, warnings and advisories for all winter weather hazards. Here's what they mean and what to do. Use the information below to make an informed decision on your risk and what actions to take.

• Winter Weather Advisory: Be Aware. An advisory informs you that winter weather may produce hazardous conditions.

• Winter Storm Watch: Be Prepared. A watch means that severe winter conditions may affect your area. NWS issues a watch to provide 12 to 36 hours' notice.

• Winter Storm Warning: Take Action! NWS issues a warning when it forecasts four or more inches of snow or sleet in the next 12 hours, six or more inches in 24 hours, or 1/4 inch or more of ice accumulation. Travel will become difficult. Delay your travel plans until conditions improve.

• **Blizzard Warning:** lets you know that snow and strong winds will combine to produce a blinding snow (near zero visibility), deep drifts, and life-threatening wind chill.

Listen to your local officials for the latest information. You can also download the *How to Prepare for a Winter Storm Guide* located at the FEMA Media Library and go to Ready.gov for information on snowstorms and extreme cold.


